- 18 The University reserves the right to conduct surprise checks at any time. The University also reserves the right to cancel affiliation of the college at any stage, if it is found that the documents produced by the management are false, interpolated and improper and the management is not able to run the college as per the norms of the Government and academic stipulations of the University, apart from any defaults/ irregularities committed which would attract legal proceedings under Law.
- The Management or any other person of the Management of the College shall not collect any capitation fee and the same is prohibited as per AP Capitation fee Act 1983.
- 20 The Management shall not allow malpractices in the examination and the same is prohibited.
- 21 The Management shall ensure the non-availability of carbonated beverages and junk foods around
- 22 The Management shall not allow the sale of tobacco products in the premises of the College and the
